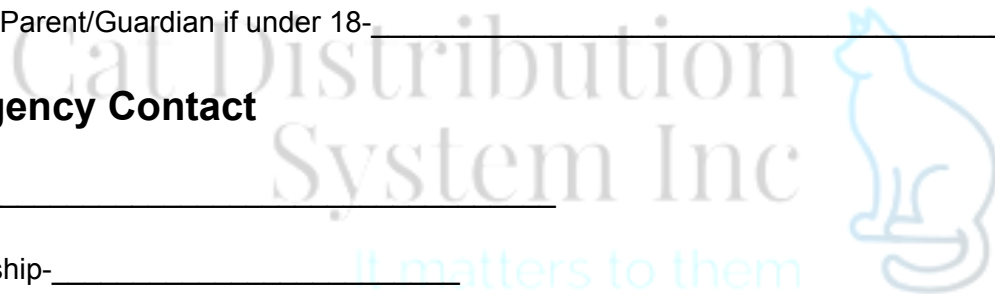

Guidelines for protecting confidentiality
